Using Verify for Local Authority Multi Service Portals (Alpha Project)

- Helping hard to reach groups achieve a GOV.UK Verify identity
- Using locally held data as additional identity evidence
- Using existing face to face processes in LAs and HAs
- Project streams:

LIGHTest: Correos Pilot

- LIGHTest will be integrated into the cloud-based e-Correos platform for trusted communications
 - Generate new positive business cases, reduce user administrative overhead and decrease cost
- Will validate and assess LIGHTest features including:
 - Use of internal LIGHTest Trust Scheme Publication Authority for trust lists issued by Correos partners
 - Extend e-Correos use beyond Europe and use certificates from Turkey and US
 - LIGHTest libraries for validation of qualified/advanced electronic signatures
 - Use of mobile IDs, derived with LIGHTest WP7
 - Use LIGHTest to verify complete electronic transactions based on a trust policy

LIGHTest: IBM Pilot

- LIGHTest will be integrated into a PEPPOL e-Invoicing infrastructure and application scenario
 - LIGHTest will be activated and integrated in different pilot scenarios
- Objectives of the pilot
 - demonstrate the ease of integrating LIGHTest in existing applications and gateways
 - explore the alternatives of integrating LIGHTest as a business application feature or as a service from a PEPPOL or eSENS GW
 - demonstrate the delegation-enabling of an application
 - LIGHTest will be used validate seals directly, as well as use delegation based on LIGHTest delegation publisher operated by a business register as well as a by the invoice issuer to authorize its employees to issue invoices
